Roles and Responsibilities of an Editor (not limited to the following):

- Make primary decisions on the merit of a written piece;
- Send conditional acceptance (if required) and written feedback for improving an article;
- Contribute substantially to the editorial and research work of the E-Newsletters, Handbooks, and Research Papers of the Legal Aid Society, Campus Law Centre; and
- Other miscellaneous editorial tasks.

Eligibility Criteria:

- The applicant must be either a 2nd year or 3rd year student enrolled in LL.B. course at Campus Law Centre, Faculty of Law, University of Delhi.
- The applicant must be a registered member of the Legal Aid Society, Campus Law Centre.
- The applicant **may or may not** be a Para-Legal Volunteer.
- We look forward to selecting candidates who are fluent in English, have a keen interest in current affairs and social issues, and possess an analytical bent of mind.
